Report a problem or mistake on this page Date modified: 2022-05-13 Canada Work Permit, or a Work Visa, is issued to eligible overseas individuals to work in that country for a specific time period. People may need to apply for a Work Visa only after getting a job offer or an employment contract from a Canadian employer. The employer must obtain from ESDC (Employment and Social Development Canada) an LMIA (Labour Market Impact Assessment), which gives them permission to recruit foreign skilled workers for occupations that cannot be filled in by citizens or permanent residents of Canada. As one of the world's leading economies Canada is a great destination for individuals seeking to work abroad. The Canadian Work Permit Visa allows business people, permanent workers, temporary workers, students and others to work in Canada. Typically, applicants need to have a job offer in hand in order to apply for the work permit visa. Two of these jobs are caregivers and agricultural workers. Caregivers who take care of the elderly, disabled or children need to have a work permit before taking up a job in Canada. The same goes for agricultural workers. Eligibility requirements to apply for a work permit from outside Canada Irrespective of the work permit you are applying for, there are certain eligibility requirements you must meet, these include: Provide proof to the immigration officer that you will leave Canada on the expiry of your work permit Proof of financial resources that can support yours and your family's stay in Canada during the work permit validity Proof that you have no history of a criminal record Proof that you are in good health and are willing to undergo a medical examination Must prove that you are not a danger to Canada's society Willingness to adhere to the conditions of your work permit Meet eligibility conditions such as language skills, biometric data, and insurance to prove that you can enter Canada Eligibility requirements to apply for a work permit from inside Canada In order to apply for a work permit from inside Canada, you must meet certain conditions. These include: Having a valid study permit Your spouse or common law partner or parents have a study or work permit You are a graduate from a program at a Canadian University You have a temporary residence permit that is valid for six months You have made a PR application from inside Canada and waiting for a response You have made or intend to make a claim for refugee protection You have been recognized as a refugee by the IRCC You are a trader, investor, under intra-company transfer or are a professional under NAFTA Dependent work visa The government of Canada allows immigration for family members under the dependent work permit category. Bringing dependents on a work permit You may be entitled to have your spouse and children join you in Canada if you obtain a job offer from a Canadian employer and have an open work permit. Your children will be eligible to attend Canadian educational institutions without having to get separate study permits. Your spouse will also be able to apply for an open work permit so that they can work in Canada. Who can be included on a dependent visa? Some members of a family such as a spouse or children can be included in the dependent visa application to Canada, whereas parents and grandparents must be sponsored by permanent residents or Canadian citizens. The sponsors must promise to support and accompany the family member or relative for a period of 3 to 10 years to ensure that they are well-settled in Canada. Family members eligible under Canada's Dependent Work Permit are: Spouse, spousal or common-law partners over the age of 16 Both parents and grandparents Dependent children, including adopted children Children under 18 whom you'd like to adopt Siblings, nephews and nieces, children under 18, orphans and unmarried Other relatives who reside in or outside Canada Children are dependent on the following criteria: Children younger than 22, unmarried or without a common-law partner Children who have become a spouse / common-law partner before they reach the age of 22 and are highly dependent on parents for financial assistance Children who are financially dependent on parents until they reach age 22 due to a certain physical impairment Dependent visa application requirements You will need to include the following to sponsor your family members for Dependent Visa for Canada Recorded evidence of your financial condition and cash flow over the past 12 months to prove you are financially stable and capable to support your family. If you are sponsoring a Canadian Dependent Visa for your child then he or she, Must be younger than 22 years Should be able to show that they rely on you financially If your child is unable to earn his or her own money for some reason, either physically or mentally, then you can sponsor him after giving enough proof of the same The child should be either your biological or adopted child To prove your relationship, you will need to provide a birth certificate or adoption certificate The child will need to undergo a medical and criminal test and may be prevented from entering the country if a criminal record or medical condition that is likely to be contagious or cause an epidemic has been found to be present. IELTS is mandatory for anyone if they are applying for Canada PR Visa. Your IELTS score will have a good influence on your CRS score in Express Entry. Thus, it is not possible to get the Canada Work Visa without passing in the IELTS test with the required bands. An overseas worker applying for Canada Work Visa must collate all the required documents from the employer. It must also be completed by all dependent children above 18 years who will be using a Representative. Canada Open Work Permit is offered to an overseas national only through one of the LMIA - Labour Market Impact Assessment exemptions. They can apply for the Open Work Permit at a port of entry outside Canada. The application can also be submitted after arrival to Canada according to the requirements of the program. In most of the cases, the Open Work Permit fee has to be paid along with the Work Permit fee. There are three categories of open work permits: Unrestricted open work permit Occupation restricted open work permit Restricted work permit The unrestricted open work permit allows a foreigner to travel to Canada and work there on any job for any employer and at any place. In the occupation restricted open work permit the person can work for any employer but only in a specified job. With a restricted work permit, the individual can change the employer but not the place of work. Canada Work Visa is offered to an overseas national who intends to work in Canada. They must not be a Canada PR Visa holder or Citizen. This is mandatory for working in Canada irrespective of the employer living in Canada or not. Canada Work Permit application from India requires verification from the labour market in Canada. It is known as the LMO - Labour Market Opinion. The application for Work Visa can be submitted only after getting positive LMO. The Canada Work Visa process involves 2 stages. In the first stage, the employer in Canada must get approval from the Government of Canada to hire overseas workers. In the second step, the designated employee must apply for obtaining the Work Visa after getting permission. The application is checked to ensure it has all the necessary documents. Incomplete applications are sent back. You may need to undergo a medical exam which can add up to three months to the processing time. The processing time can vary based on the country You might also need to give your biometrics with the application An officer will check the credentials of the employer who has hired you An officer will check if you qualify for a work permit After approval of your application you will get a letter giving you permission to work in Canada You must take this letter when you leave for Canada You will get your Work Permit on arrival in Canada It will have details of the type of work you will do, mention the employer and the place and duration of your work Yes, in most cases, they can work in Canada. They will need a work permit to work in the country. However, they must individually apply for the work permit. In some cases, they can also apply for an open work permit which allows them to apply for any job with any employer. The employer must get an LMIA to employ the person. The spouse dependent work permit will be processed in 1 to 3 months. Your spouse can work full time in Canada. Your spouse will not be required to clear the IELTS Your spouse can start working as soon as they arrive in Canada There is no minimum work experience required to file for a spouse dependent work permit Your spouse can stay with you as long as your visa is valid You can apply for spouse dependent work permit as soon as you get your study/work permit in Canada. You will get them approximately around 15 days from arrival. The visa is not job-specific, so applicants are required to meet similar requirements as applicants for other types of job visas. These include not needing the Labor Market Impact Assessment (LMIA) or an offer letter from an employer who has paid the compliance fee. However not everyone is eligible for the open work permit visa. Individuals including foreigners who need a job to support themselves Applicants for PR visa Dependent family members of these applicants Spouses of skilled worker residents Spouses of foreign students Foreign nationals currently in Canada whose work permit will soon expire and have applied for permanent residence Refugees, protected persons, and their relatives Participants in working holiday programs International students who completed their post- secondary education in Canada You get an approval letter - known as the Port of Entry (PoE) Letter of Introduction - stating that you are allowed to work in Canada. This is not a work permit in itself, and will have to be presented at the PoE when you travel to Canada. Once your work permit application is approved, you can travel to Canada with the PoE Letter of Introduction. You will get your work permit in Canada at the PoE the day that you arrive in the country. A Canadian work permit will specifically mention - - The employer that you are allowed to work for, - The employer that you can work for, - How long can you work for, and - Where can you work in the country. A 9-digit Social Insurance Number (SIN) will be required for working in Canada and for accessing government benefits and programs. You should be applying for a SIN - at the nearest Service Canada office - as soon as possible after arriving in Canada. A common-law partner or spouse that intends working in Canada will have to apply for their own Canadian work permit. Usually, the spouse or partner will have to meet the same rules and requirements as the work permit holder. The spouse or partner might be able to apply for an open work permit for Canada Dependent children of the Canada work permit holder might apply to come with the individual to Canada. If they wish, such dependent children might apply for a study permit of Canada or a Canadian work permit The Canada work permit is to be printed after the border services officer has checked the documentation, confirming that you can enter Canada. In case of any mistake on the printed work permit, ask the border services office concerned. To be able to stay on in Canada on a permanent basis after entering the country on a Canada work permit, the individual must qualify under any of the permanent resident categories available. For example, the Express Entry system, Canadian PNP, Agri-Food Pilot, Atlantic Immigration Pilot etc.
